Birbhum, from the interested, resourceful and experienced agencies in four step bid system : **Step-I** i.e. deposition of requisite amount of Earnest Money Deposit **Step-II** i.e. submission of documents as per following qualification requirement:- (i) Possessing valid VAT, Professional Tax Clearance Certificates and Provident Fund A/c No., (ii) At least once within a period of last five years (a) the Bidder should have credential to execute similar nature of job in a single contract valuing minimum of Rs.150 lakhs directly under a Government organisation/PSU/MES / Reputed Private organisation (b) have turn over not less than Rs. 250 lakhs in a year, (c) have Net Worth Value not less than Rs. 100 Lakhs, (iii) Audited balance sheet for last three years. **Step-III** i.e. i) Execution plan within stipulated time period, ii) Statement of Resource (Fund, skilled manpower, machineries) to be mobilized.. (Techno-Commercial Bid) and **Step-IV** i.e. Price Bid.

Construction of 10 (ten) Nos. Bolcks of 'B' Type quarters each consisting of six (06) residential units at Bakreswar Thermal Power Project Township, P.S. Sadaipur Dist. Birbhum, West Bengal.

**Time of Completion:** 18 (Eighteen) months.

All tenders including its various steps shall be opened in presence of attending tenderers.
