Sealed Tenders in prescribed format are invited by the Chief General Manager (P&A), The West Bengal Power Development Corporation Limited, from the resourceful, well experienced and financially sound Agencies/Companies in three steps bid system, Step-I : Earnest Money Deposit, Step-II : Containing Qualifying Requirement and Step-III: Price Bid, for the job of Deployment of Watch Dogs with Handler for guarding the properties/premises and other security related jobs at Santaldih Thermal Power Station (STPS), Santaldih, Purulia, Bandel Thermal Power Station (BTSP), Tribeni, Hooghly, Kolaghat Thermal Power Station (KTSP), Mecheda, Purba Medinipore and Bakreswar Thermal Power Project (BkTPP), Birbhum. The requirements of Dogs with handler for each Power Station/Project are given below:-

1. **Description of requirements :-**

The number of **required dogs with handler** as mentioned above against requirement of each **Power Station/Project may increase/decrease subsequently, if required to the extent of $\pm 25\%$.**

- Eligibility Criteria:** a) The Agency/Company must have experience in deployment/supply of Watch Dogs with Trained handler **in a single contract or more than One contract, engaging 10 (ten) or more Dogs with handler in Power Utilities or industry for at least one year** under Government Organizations/Undertakings/Autonomous Body/Private Industry representative of Industrial Houses/factory, to be supported by the Performance Certificate of end User. (b) Current IT Registration Certificate, PT Registration and enrolment. (c) PF Establishment Code and ESI Registration. (d) Audited Balance Sheet and Profit & Loss account for the last three years. (e) **Minimum 5 (five) years experience in deployment of Dogs with handler independently.**
- The Agency/Company must have their own **KENNEL**, Qualified Trainer & Veterinary Doctor. The Handler must be well trained, within age group of **45 years** as on 30.04.2010.
- The dogs are to be from **Doberman, Labrador, Rottweiler and German Shepherd Breed** the age of the dogs will be between 2 – 4 years.
- Sale of Tender Document:** Tender document will be issued on the basis of written application from the Office of the Chief General Manager (P&A) from **26.04.2010 to 07.05.2010** on all working days, between 11.00 hrs. to 15.00 hrs., except Saturdays & holidays. **Issuance of tender documents will not construed to mean that such intending bidders are automatically considered qualified.** Request for tender paper **by post will not be entertained.**

6. **Cost of Tender Documents:** Rs.2,000/- (Rupees two thousand only) [Non-refundable] by Cash to be deposited at Cash Section at above address for purchasing Tender documents.
7. **Earnest Money:** Rs.25,000/- (Rupees twenty five thousand only) (interest free) to be deposited in separate sealed envelope.
8. **Contract Period:** Contract will be for 18 (eighteen) months but initially order will be placed for one year which may be extended for further period of 6 (Six) months at the same ordered terms and conditions at the sole discretion of the management depending upon satisfactory performance over last year.
9. **Pre-Bid discussion:** On **11.05.2010** at 15.00 hrs in presence of attending intending tenderer. The clarification(s)/decision against point/query as would be given by WBPDCL and such discussion shall form the integral part of this NIT& shall be binding on all the tenderers. The Agencies who purchased Tender Documents but not attended the Pre Bid discussions shall also comply to the decision of Pre bid discussions.
10. **Submission of Tenders:** Upto 14.00 hrs. of **14.05.2010** to be submitted in three parts i.e. 1) Earnest Money 2) Qualifying Requirement 3) Price-Bid in a separate sealed envelop, indicating tender notice no., on the envelop.
11. **Opening of Tender:** Step-I i.e. Earnest money and Step - II i.e. qualifying requirement will be opened on **14.05.2010** at 15.00 hrs. in presence of attending bidders. Price Bid (Step –III) of the qualified bidders in Step –I & Step-II will be opened on **28.05.2010** at 15.00 hrs.
12. The Validity of Tender will remain effective for 6 (six) months from the date of opening of Price Bid.

The Corporation reserves the right to accept/cancel any all tenders without assigning any reason whatsoever. The corporation does not bind itself to accept the rate quoted by the lowest bidder and reserves the right to accept or to reject any or all the tenders or to split the whole work for entrusting the same to more than one agency/company.
