**Construction of Market Complex (Phase-I) consisting of Market place & Co-operative store for Sagardighi Thermal Power Project Township at mouza Balarambati, P.S. Sagardighi. Dist. Murshidabad, West Bengal.**

**Time of Completion:** 18 (Eighteen) months.

After finalization of the Step-II bid, fulfilment of the qualification requirement & the Techno-Commercial part,. Step-III, the Price Part of the Bid Step-IV of the eligible tenderers will be opened subsequently at a later date with an intimation to only such bidders. All tenders including its various steps shall be opened in presence of attending tenderers.

The WBPDC does not bind itself to accept the lowest tender and qualification of tenderer will be adjudged as per sole discretion of WBPDC authority.
