

Tender for International Competitive Bidding for Supply of 1.2 Million MT of Imported Coal to the Power Plants of WBPDCCL

Tender Notice no: WBPDCCL/Tend-Adv/PR/10-11/66/Corp dtd. 18.8.2010

Sealed tenders are invited in four part bidding system from experienced parties for **Supply of Non-coking (steam) Coal of Foreign origin for Different Power Stations under WBPDCCL**. The four parts of the tender would be;

1. EMD – Earnest Money Deposit
 2. Qualifying Requirement
 3. Techno Commercial Bid
 4. Price Bid
- i. Quantity of supply – 1.2 Million Metric Tonnes
 - ii. Period of Contract – 12 months
 - iii. **Minimum Qualifying Requirement**
 - a. The bidder should have experience supply of at least one Million Metric Tonne of Imported Non-coking Coal per year to any Power Utility in India directly or through PSU, during any 2 (two) financial years within last 5 (five) financial years. In support of the above, the bidder must enclose performance certificate.
 - b. The Bidder must be financially sound and furnish a firm and unconditional 'Letter of commitment' for **INR 100 crore** (Rs. One Hundred Crore) / **USD 22.5 Million** from any bank (As per list of Banks selected by WBPDCCL provided in the tender documents) in India, valid for a minimum of one year and six months.
 - c. The Bidder must also possess net worth of **INR 100 Crores** / **USD 22.5 Million** in any of the three financial years i.e. 2007 – 08, 2008 – 2009, 2009 - 2010.

- d. The bidder must enclose authenticated documents relevant to establish the proof of fulfillment of pre-qualification criteria and audited financial statements for the preceding three financial years i.e. 2007-2008, 2008-2009 & 2009 -2010 duly certified by a Chartered Accountant.
- e. The bidder must have pre-qualification requirement in his / its name.
- f. The bidder should have its Main office, Branch office or Liaison office in India and preferably in Kolkata.
